第一條 (目的)

為鼓勵外籍研究生能完成學業以及獎勵學業表現優秀的學生,醫學工程學院(以下簡稱本學院)設立臺北醫學大學醫學工程學院外籍研究生獎勵學金實施要點(以下簡稱本要點),提供優秀外籍學生獎勵學金。

第二條 (經費來源)

本要點之經費來源為「防疫智慧生醫器材研究基金」、「智慧型生醫材料於藥物釋放/再生醫學應用研究基金」 及「醫學工程學院基金」。

第三條 (申請條件)

獎勵學金申請條件:

- (一)申請者須為醫學工程學院研究所學生。
- (二)學生於申請時未獲其它獎助學金補助。
- (三)新生須提供前一學歷之成績單以及讀書計書。
- (四)在學生的前一學年度總平均成績須高於80分。

第四條 (委員會組成)

本院獎勵學金審查小組置委員五人,學院院長為當然委員及召集 人,其他委員由各所(含學程)主管擔任。

第五條 (金額及發放方式)

獎勵學金之金額及發放方式:

- (一)每月至多新台幣壹萬陸千元整,由本院獎勵學金審查小組 綜合考量募款金額、申請者實際需求及學業表現後決定之。
- (二)每三個月核發一次,共核發十二個月。
- (三)學生須於每學年重新申請本獎勵金。

第六條 (停止發放)

受獎生有下列情事者,得停止發放獎勵學金或取消其受獎資格:

- (一) 有休學、退學、開除學籍、轉學或轉系所等情事
- (二) 違反校規或違紀案件等異常事件
- (三)出境超過15天以上者,出境期間停止獎助學金發放,直至回國後方予繼接續發放,惟不補發出境期間之獎勵學金。但出境事由如果屬於進行出國交換學生事宜或其他原因經所或學程審查同意者,則不在此限。
- (四)受獎者經查申請過程若有偽造或不實之情事,撤銷其受獎 資格,已領取之獎勵學金應予繳回,並喪失未來申請資格。

第七條 (申請方式)

申請方式:申請人於每學年度10月1日至10月31日,備齊下列文件至醫工學院提出申請:

(一)新生:

- 1.申請表(附件1)。
- 2.讀書計畫一份。
- 3.前一學歷成績單一份。
- 4.未獲其他獎勵學金之切結書(附件2)。

(二)在學生:

- 1.申請表(附件 1)。
- 2.前一學年度成績單一份。
- 3.未獲其他獎勵學金之切結書(附件2)。

第八條 (特殊情事)

如有特殊情事得以專案申請,由院長召開審查委員會另案討論。

第九條 (法規核決權限)

本要點經醫工學院院務會議通過,並送學生事務會議通過後公告施行,修正時亦同。

Taipei Medical University College of Biomedical Engineering Regulations for Awarding International Graduate Student Scholarships/Grants

Article 1 (Purpose)

To help international graduate students finish their academic studies and to award students with excellent academic performance, the College of Biomedical Engineering (hereafter, the "College") has formulated these Taipei Medical University College of Biomedical Engineering Regulations for Awarding International Graduate Student Scholarships/Grants (below, the "Regulations"), and provides excellent international graduate students with incentive scholarships.

Article 2 (Funding sources)

The funding sources of these Regulations are the Anti-pandemic Smart Biomedical Device Research Fund, the Smart Biomaterials Applications in Drug Release/Regenerative Medicine Research Fund, and the Biomedical Engineering College Fund.

Article 3 (Application requirements)

Incentive scholarship application requirements:

- (1) Each applicant shall be a graduate student of the College of Biomedical Engineering.
- (2) At time of application, the student shall not be receiving subsidies from other scholarships.
- (3) New students shall provide academic transcripts for their prior education and a study plan.
- (4) For existing students, their overall average grades earned in the previous academic year shall be higher than 80 points.

Article 4 (Committee composition)

The College's Incentive Scholarship Review Panel shall consist of five

committee members. The Dean of the College shall be the ex-officio committee member and convener; other committee members shall be supervisors of the institutes (including programs).

Article 5 (Amount and distribution method)

Incentive scholarships' amounts and distribution method are as follows:

- (1) The funding shall be no more than NT\$16,000 per month. The actual amount shall be determined by the College's Incentive Scholarship Review Panel, taking into account the current overall fund-raising status, and the applicant's actual need and academic performance.
- (2) The scholarship shall be distributed once every three months, and, in total, 12 months of scholarship shall be distributed.
- (3) Students are required to re-apply for the incentive scholarship each academic year.

Article 6 (Cessation of distribution)

In the event of any of the following circumstances applying to the scholarship awardee, scholarship distribution shall be stopped and the student's eligibility for the scholarship shall be cancelled:

- (1) The student suspends their studies, withdraws from school, is expelled from school, transfers to another school or another department, etc.
- (2) Exceptional events, such as violation of school rules or disciplinary violation, occur.
- (3) For students have left Taiwan for more than 15 days, scholarship funding distribution will be suspended during their period abroad, and only continued after they return to Taiwan. No scholarship funding will be supplemented for the period abroad. However, where the time abroad is related to student exchange matters or other reasons that have received institute or program review approval, these restrictions shall not apply.
- (4) If investigation finds that there is any forgery or misrepresentation in the awardee's application process, the awardee's eligibility for the scholarship shall be revoked, any incentive scholarship funding already received by the awardee shall be returned, and the awardee shall lose their eligibility to apply for future scholarships.

Article 7 (Application method)

Application method: The applicant shall prepare the following documents and file an application with the College of Biomedical Engineering, during the Oct. 1 to Oct. 31 period:

- (1) New students:
 - 1. One application form (attachment 1)
 - 2. One study plan
 - 3. One complete set of transcripts for previous education
 - 4. An affidavit guaranteeing no receipt of other incentive scholarships (attachment 2)
- (2) Existing students:
 - 1. One application form (attachment 1)
 - 2. One complete set of transcripts for previous education
 - 3. An affidavit guaranteeing no receipt of other incentive scholarships (attachment 2)

Article 8 (Special cases)

In the event of any special circumstances, an application may be submitted in project form. The Dean shall then convene a review committee meeting to discuss the case separately.

Article 9 (Statutory approval authorization)

After passage by the College of Biomedical Engineering College Affairs Meeting, then by the Student Affairs Meeting, these Regulations shall then be promulgated and take effect. The same shall apply in the event of any revision.
